## **Notes**

Applications for registration of an UAS will be assessed on a case-by-case basis. The average processing time is 4 weeks after submission, presuming that the documents are received in good order. The processing time includes time required for assessment of submitted documents and coordination with other competent security agencies for security vetting prior to certificate issuance. Applicants are encouraged to submit their application well in advance of the date of their unmanned aircraft activity.

For the UAS to be registered, the owner must be:

- The Government of Rwanda or one of its institutions;
- A Rwandan citizen or permanent Rwandan resident of 18 years of age or older. (If the owner is less than 18 years of age, a person 18 years of age or older must register the UAS)
- Bodies incorporated under the Rwandan laws.

For non-Rwandan citizen or non-permanent Rwandan resident, the UAS should be temporarily registered by a person who is a Rwandan citizen or permanent Rwandan resident or body/entity incorporated under the Rwandan laws on behalf of the owner for the duration of the intended operations/stay in Rwanda.

The original application must be submitted to the Rwanda Civil Aviation Authority, at Kigali International Airport.

Please note that the receipt of the Certificate of Registration does not provide Authorization to operate your UAS. Application for operating certificate (Permit) is made on Form **RCAA-Form-UAS002A** 

Operating unregistered UAS or without operating certificate may result in regulatory and criminal sanctions. The RCAA may assess administrative fines as provided by these regulations. Offenders may also be liable to prosecution under existing laws such as the Penal Code.

It is an offence to make, with intent to deceive, any false declaration or statement for the purpose of procuring the grant, issue, renewal or variation of any certificate, license, approval, permission or other document. Therefore, any person who knowingly and willfully makes a false declaration or statement in an application for registration of his or her UAS will be prosecuted under Penal Code.
